Line of Duty Death of Police Officer Peter Figoski

In the early morning hours of December 12, 2011, Police Officer Peter Figoski was shot and killed while responding to a home invasion robbery in Cypress Hills, Brooklyn. When Officer Figoski and his partner, Glenn Estrada, arrived, two officers were already on the scene interviewing the victim and a witness. Unknown to the officers, the robbery perpetrators were still inside the basement apartment hiding. While struggling to apprehend one of the suspects, the second suspect appeared and shot Officer Figoski in the head. Officer Estrada, upon hearing the shot and seeing the armed male fleeing, broke from the first suspect, pursued the gunman on foot, and apprehended him after a two block foot chase. Officer Figoski is survived by four beautiful daughters and was posthumously promoted to Detective 1st Grade. Our condolences and prayers go out to the Figoski family and members of the New York City Police Department. May God watch over them and provide them peace in this time of sorrow.

In response, the NY Post, along with the New York City Police Foundation, set up a scholarship fund for his daughters. As of January 5th, the fund had nearly reached 2 million dollars. In addition,

Line of Duty Death of Special Agent John Capano

On December 31st, 2011, Special Agent John Capano of the United States Department of Justice - Bureau of Alcohol, Tobacco, Firearms and Explosives was killed in the line of duty while attempting to subdue a robbery in progress at a pharmacy in Seaford, Long Island. Special Agent Capano was off-duty when becoming aware that a robbery was taking place, and immediately took action. Agent Capano's father, Jimmy Capano, is a retired NYPD detective. The following are words that were expressed by Acting Director B. Todd Jones:



Special Agent Capano was a 23-year veteran agent with the ATF, who will be mourned by his wife, son and daughter and thousands of friends and colleagues. Our thoughts and prayers are with them now.

His tragic death is another reminder that our brave agents, like all law enforcement officers, are always on the job, ready to respond to violent criminal acts.

Police Fatalities Increase 13% in 2011 as compared to 2010; 42% since 2009

According to the National Law Enforcement Memorial Fund (NLEOMF), a total of 173 federal, state and local law enforcement officers died in the line of duty during calendar year 2011. 153 law enforcement officers died in the line of duty in 2010, and 117 in 2009. This represents a 42% increase in line of duty law enforcement deaths from just two years ago. For the first time in 14 years, more officers died from firearms-related incidents than traffic-related incidents. Sixty-eight officers were shot and killed in 2011, up 15 percent from 2010 when 59 officers died from gunfire. The number of officers killed by firearms has now risen during each of the past three years. Traffic-related incidents claimed the lives of 64 officers this year, a 10 percent decrease from 2010 when 71 officers died on the roadway.

Police Commissioner, Nassau County Police Department

On January 2nd, Thomas V. Dale was sworn in as the Police Commissioner of Nassau County. A member of the NYPD since 1970, Commissioner Dale has served in managerial positions during some of the most tumultuous times in the NYPD's recent history. In a career spanning more than four decades, Commissioner Dale has served in the patrol and detective bureaus, organized crime control and the terrorist task force. From 2003 to 2010, he commanded Patrol Borough Queens South, supervising eight precincts during a time when major crime declined 17 percent.

Commissioner Dale also developed the security plan for the 2004 Republican National Convention in New York City and orchestrated initial patrol operations on September 11, 2001, when he was one of the first senior law enforcement officials on the scene.

In his role as Chief of Personnel, Commissioner Dale managed a \$5.8-million budget for his office and was responsible for recruitment, promotions, transfers and medical, pension and personnel evaluations.
